

Avios Thank You Appeal – Awarding T&Cs – HSC Northern Ireland

1. The Avios Fund (The Fund) consists of 305 million Avios points donated by Avios Group (AGL) Limited and British Airways Executive Club (BAEC) members during the Avios Thank You Appeal (the Initiative)
2. AGL will distribute the Fund to 5,090 NHS and HSC Northern Ireland workers (Nominees)
3. Each Nominee will receive 60,000 Avios
4. The Fund will be distributed proportionally to NHS Organisations in England and Northern Ireland, based on the number of employees in each NHS Organisation
5. These T&Cs cover the process for the distribution of the Awards to HSC Northern Ireland workers
6. Nominees will be selected by their local Organisations (e.g. Trusts) by 2 November 2020
7. Each Organisation assumes full responsibility in selecting their Nominees
8. NHS Organisations will advise Nominees either via email or phone if they have been selected by 02 November 2020
9. Nominees should be employed in the relevant Organisation at the time of nomination
10. Nominees will need to be a member of the British Airways Executive Club (BAEC) in order to receive the Avios points
11. AGL will contact each nominee on the email provided to AGL by HSC Northern Ireland. Nominees must provide their BAEC details by filling in an online form, by 25 November 2020, in order to receive their Avios Award within a week from submission
12. Avios Awards will be awarded by 3 December 2020
13. Nominees that provide details after 25 November will still be able to receive their Avios Award
14. Nominees that provide details between 25 November and 31 January 2021 will receive their Avios Awards by 15 February 2021
15. Avios Awards will not be awarded to any Nominee submitting their details after 31 January 2021.
16. Only 1 Award per Nominee is permitted
17. By providing their personal and BAEC details, including membership ID, Surname and email address, each Nominee agrees to share the necessary data in order to receive the Avios points
18. All data will be treated in accordance with the [British Airways Privacy policy](#)
19. By submitting a nominee list, each Organisation confirms they have the Nominee's consent to share their personal details with AGL, with the sole purpose of processing the Avios Awards
20. Recipients will be asked to give permission to AGL and British Airways to include their name and job title in a resulting press release and media opportunities. The recipient may be asked to give a quote for a press release, have their photo taken to use with press, and may be asked to take part in press interviews, should their HSC Northern Ireland contract allow. Nominees have the right to refuse.
21. AGL reserves the right to adjust the distribution of Avios points to NSC Northern Ireland workers, based on the final number of nominees that provided their BAEC details
