Bradley Manor Nursing Home

1) How many adverse incidents have been sent to the Belfast Trust from Bradley Manor since January 2018?

There are 916 incidents recorded on DATIX for Bradley Manor in the period 1 January 2018 – 18 November 2022

2) How many allegations of abuse of a vulnerable adult (APP1) have been sent to the Belfast Trust from Bradley Manor since January 2018?

Between January 2018 and July 2022 BHSCT used the ASP1 referral form. The APP1 form has been used from July 2022 to date. The Adult Protection Gateway Team only has data for referrals received by this Team. From January 2018 – June 2020 and then from July 2022 to date. ASP1 referrals could have been made to places other than APGT.

- 2018: 19 ASP1 referrals from Bradley Manor into the Adult Protection Gateway Team
- 2019: 21 ASP1 referrals from Bradley Manor into the Adult Protection Gateway Team
- 2020: 2 referrals from Bradley Manor into the Adult Protection Gateway Team
- 2021: 15 referrals (13 ASP1 referrals) from Bradley Manor into the Adult Protection Gateway Team
- 2022 to end of October 2022: 8 ASP1 referrals from Bradley Manor into the Adult Protection Gateway Team

3) How many of the above allegations of abuse of a vulnerable adult were substantiated after investigation?

Adult Safeguarding investigations are complex multi-faceted processes. Issues and themes can arise during an investigation that were not part of the initial reason for referral. Conclusions regarding the substantiation of abuse are not recorded in this manner.

In order to provide this level of detail, a manual trawl of records would be required. We estimate that compliance with this request for information would exceed the appropriate costs limit. Under Section 12 of the Freedom of Information 2000, the limit has been specified as £450 and represents the estimated cost of one or more persons spending 18 hours in determining whether we hold the information, locating, retrieving and extracting this information.

There were 5 residents who fractured their hips during the period 1 March 2020 – 18 November 2022
