We have approximately 50 service users awaiting Care Home/Supported Living placements. Some of these are urgent but the majority are not.

Total numbers of residents per section have been provided. To provide numbers of residents for each private sector provider against their costs would be considered exempt under Section 43 Commercial Interests especially where numbers are very low.

[Section 43: commercial interest](#)

Section 43 of the Act sets out an exemption from the right to know if:

- the information requested is a trade secret, or
- release of the information is likely to prejudice the commercial interests of any person. (A person may be an individual, a company, the public authority itself or any other legal entity).

The outcome of the above public interest test is that it would not be in the public interest where the disclosure would prejudice the commercial interests of external provider(s): making public pricing information. In reaching this decision to withhold some of the information requested, the Trust has considered fully its commitment to ensuring openness and transparency, where reasonably practicable, in all its activities.
