Trust System Oversight Measures Report - November 2025 including areas of escalation under the Support and Intervention Framework (SAIF).

The System Oversight Measures (SOMs) Report is attached for information and assurance.		
The Report to the Trust Board provides a summary of the Trust performance against key SOMs targets to end of November 2025. The Report also includes data related to patient experience and a summary of those areas which have been escalated by the Trust at Levels 1-5 under the Department of Health's Support and Intervention Framework (SIAF).		
The SDP has now been replaced by the Strategic Outcomes Framework (SOF) which sets out the long-term direction to the system and the System Oversight Measures (SOMs) which convey the shorter-term priorities.		
It was envisaged that monitoring and reporting of the SOF/SOMs would be effective from 1 April 2025. However, most reports for the SOMs built regionally on encompass became available on the 7th July 2025, with others to be developed for reporting at quarter 3 and 4.		
As there are no agreed baselines for levels of activity to be delivered within the SOMs framework, an activity summary for outpatient attendances and elective admissions and daycases will be included going forward from 2026.		
This will include a comparison of the current month to the equivalent month in the previous year and will enable us to provide a robust comparison of encompass activity.
