*The Trust holds information relating to referrals received by Adult Protection Gateway Team (APGT) between 2020 and 2022. However, it does not hold the requested information in a format that identifies referrals from care homes. To determine this would require a manual review of individual records held in multiple locations. The Trust therefore considers that compliance would exceed the appropriate limit under Section 12(1) of the Freedom of Information Act 2000.

Belfast Trust does not hold information in the form requested and is only required to provide recorded information that it holds and is not required to create new information or reclassify existing records to meet a request. Accordingly, this information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (Personal Information), as its release would be unfair and unlawful.

- h. Any anonymised summary information showing recurring themes or patterns identified through safeguarding investigations concerning Bradley Manor during this period.

Belfast Trust does not hold any recorded anonymised summary or thematic analysis specifically identifying recurring themes or patterns from safeguarding investigations concerning Bradley Manor Nursing Home for the period requested.

In accordance with Section 1(1)(a) of the Freedom of Information Act 2000, we can confirm that Belfast Trust does not hold the information requested.

Some figures have been withheld and replaced with less than five (<5). This is because disclosure of small numbers has the potential to identify individuals. The information is therefore exempt under Section 40(2) of the Freedom of Information Act 2000 - Personal Information relating to a third party. Its release would contravene the data protection principles set out in the UK GDPR.
