# **Autism Services for Children**

I am writing to you under the Freedom of Information Act 2000 to request the following information from Belfast Health & Social Care Trust. In relation to ASD services specifically, please provide:

#### Current average wait time from referral to diagnosis of ASD

Belfast Trust do not record this data and it would require in excess of 18 hours work to try to provide an answer.

The Trust considers that the cost of retrieving the information would be above the 'Appropriate Limit', as defined by the Freedom of Information Act under Section 12. Section 12 of the Freedom of Information Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit. The limit has been specified as £450 for public authorities such as Belfast Trust. This represents the cost of one or more persons spending 18 hours in determining whether we hold the information, locating, retrieving and extracting this information.

We can however provide you with the following:

For Q1 we would need to know which children got a positive diagnosis of ASD, date referred and when feedback was received. We can't do this without a manual count. We are not asked to capture this info routinely. What we can do is provide, as per below, the standard waiting time report for commencing assessment – this is what we are asked to report on routinely and may be a helpful proxy for you.

We have also developed a **Directory of Services**, which includes information and contact details for other organisations that can provide help and support.

#### What services does the Trust provide at the point of diagnosis?

As soon as a referral is received for intervention, parents get immediate access to our 'First Steps' webinars, which provide foundation knowledge on autism along with advice and strategies. A Directory of Services is also provided. Parents are then invited to attend a face-to-face session, along with other parents, to get to know the service and discuss their child or young person's needs.
