# Question 1:

# What is the main Radiology (RIS/CRIS) system that your Trust/Health Board runs?

RVH- Wellbeing CRIS- supplied by Philips Healthcare as part of a managed equipment Service

BCH- GE Healthcare Centricity RISi, supplied by Medipass as part of a Managed Equipment Service

MIH, MPH, RBHSC, Breast service - Sectra (NIPACS) - Managed centrally for Northern Ireland by Business Services Organisation

Note abbreviations: RVH – Royal Victoria Hospital, BCH – Belfast City Hospital, MIH – Mater Informorium Hospital, MPH – Musgrave Park Hospital, RBHSC – Royal Belfast Hospital for Sick Children

#### Who is the supplier of this system?

#### What is the annual cost of the system?

- RVH and BCH systems are part of a much wider managed equipment service and the exact costs cannot be separated from the broader MES. Additionally this information is commercially sensitive and is exempt under Section 43 Commercial Interests
- NIPACS (Sectra) contract is not managed by the Trust. This is managed centrally for Northern Ireland by Business Services Organisation. BSO would need to be contacted in relation to these costs. Their email address is FOI.BSO@hscni.net

#### How long is the contract for the system, and when does it expire?

- RVH, BCH- the NIPACS+ project, which is at an advanced stage having identified a
  preferred bidder, will incorporate the RVH and BCH sites.
- NIPACS- business case for replacement submitted to the DoH NI for replacement to cover all of NI Radiology including RVH and BCH sites. It is hoped that the contract can be awarded to the successful vendor in the coming months.

#### What is the overall lifetime cost of the system?

 RVH and BCH part of MES and lifetime costs cannot be extracted from the overall project cost. Additionally this information is commercially sensitive and is exempt under Section 43 Commercial Interests.
