Estates and Facilities Management

I am writing to request information under the Freedom of Information Act 2000. Could you please provide the following details regarding your Estates and Facilities Management at the following: Royal Victoria Hospital, Muckamore Abbey Hospital, Maternity Hospital, Children's Hospital, Musgrave Park Hospital, Mater Hospital, Knockbracken, and Belfast City Hospital?

Facilities Management (hard and soft FM) is delivered across two teams, Estates Services and Patient Client Support Services (PCSS)

Health and Safety and Legal support - as per the clarification received to refer to the head count of the Facilities and Estates team- Estates and Facilities Management only, I am referring to man managed services related to the operation and maintenance of the organisation's physical estate, this would not include the Health & Safety or Litigation teams which both sit within the Risk & Governance Department, Medical Directorate.

Could you please provide the following information for each hospital:

Estates and Facilities Management

- Is your Estates and Facilities Management handled in-house or outsourced?

The Belfast Health & Social Care Trust has a large Estates Department that manages hard FM (incl. Fire Safety & Asbestos Management) across its estate. This includes ensuring that each space in the building is maintained to meet the needs of occupants. The Estates Team are supported by various contractors who are engaged as required.

Patient Client Support Services are delivered by staff in house. PCSS covers Cleaning, waste management, security and porterage

- If outsourced, which organisation currently holds the contract, and when is the contract due for review?

The Estates Department have approximately 300 staff

In relation to *Cleaning, waste management, security, porterage* the Patient & Client Support Services Team have approximately 1,700 staff.
