COVID-19 Vaccination Adverse Drug Reaction Monitoring

It is important to report any side effect experienced to the COVID-19 vaccine to the Medicines & Healthcare products Regulatory Agency (MHRA) via a Yellow Card. Adverse reactions and incidents must also be reported on the Trust incident reporting system (Datix), to the Public Health duty room and to the Head of Pharmacy. This will enable surveillance of the novel vaccine to be undertaken and will enhance the safe use of the vaccine on an ongoing basis. Please consider recording any adverse event as a **priority** and encourage colleagues to do the same.

Encourage all Healthcare staff and recipients of the vaccine to complete a Yellow Card report Healthcare staff may register for Yellow Card Vaccine Monitor

The MHRA runs the Yellow Card Scheme which collects and monitors information on suspected safety concerns on medicines and vaccines. This scheme relies on voluntary reporting of suspected safety concerns by **Healthcare Professionals** or **Members of Public.**

There is a dedicated coronavirus Yellow Card site for healthcare professionals and Members of the public/Vaccine recipients to report suspected side effects of any medicines or vaccines they administer/receive.

Information required as a minimum to complete a report

Information on the person who experienced the side effect (patient identifiable data removed)

The name of the vaccine that caused the side effect

A description of the side effect

Any other medicines taken at the same time

Any other health conditions

A request to workers in the health and care sector from the MHRA
